RETURN & REFUND POLICY

Introduction

Our policy lasts 30 days. If 30 days have gone by since your purchase, unfortunately we can't offer you a refund or exchange.

To be eligible for a return, your item must be unused and in the same condition that you received it. It must also be in the original packaging. Our refund policy only applies to goods sold. All services, including but not limited to group and private sessions or consulting and monthly plans, are not returnable or refundable unless specified by contract.

Several types of goods are exempt from being returned. Perishable goods such as food and beverages cannot be returned.

To complete your return, we require a receipt or proof of purchase.

Refunds (if applicable)

Returns must be made in person at the Brendle Systems location where the item was originally purchased. Once your return is received and inspected, your refund will be processed, and a credit will automatically be applied to your credit card or original method of payment, within a certain amount of days. If shipping is required to return it to Brendle Systems, you will be solely responsible for any and all related shipping and handling costs.

Late or missing refunds (if applicable)

If you haven't received a refund yet, first check your bank account again. Then contact your credit card company, it may take some time before your refund is officially posted. Next contact your bank. There is often some processing time before a refund is posted. If you've done all of this and you still have not received your refund yet, please contact us at service@g-nat.com.

Sale items (if applicable)

Only regular priced items may be refunded, unfortunately sale items cannot be refunded.

Exchanges (if applicable)

We only replace items if they are defective or damaged. If you need to exchange it for the same item, bring your item to the Brendle Systems location where you originally purchased the item within 30 days of purchase and an exchange for an in-stock item of the same price will be completed.
